**NEW BUSINESS**

**Public Hearing – Lawrence Road Site Restoration, LLC Conditional Use Permit**

A motion was made by Supervisor Sutherland, seconded by Trustee Dame to open the Public Hearing for the Lawrence Road Site Restoration, LLC Conditional Use Permit. Motion carried.

Don Beagle, General Manager of Lawrence Road Site Restoration, LLC, spoke to the board regarding the Conditional Use Permit request and answered questions from board members. Discussion followed regarding the term of the permit, moving the start time to 8:00 am, time frame for completion of the restoration, how the product is weighed without a scale, restoration to lot No. 4, the need to refile for the permit, with signatures by the owners of the company instead of the manager, and other matters.

A motion was made by Supervisor Sutherland, seconded by Trustee Dame to close the Public Hearing for the Lawrence Road Site Restoration, LLC Conditional Use Permit. Motion carried.

**Lawrence Road Site Restoration, LLC Conditional Use Permit Approval**
