OLD BUSINESS

Lawn Care RFP

Supervisor Sutherland spoke in support of Perry's Pinnacle, citing the positive reviews he had received regarding this company. Short Discussion followed. Motion was made by Supervisor Sutherland, seconded by Treasurer Sauers to approve using Perry's Pinnacle for lawn care for Norvell Township properties for the 2022 year at a cost of \$715.00 per mowing. Resolution 2022-08 – Confirmation of the Roll of the Wamplers Heights SAD for Road Repairs

Supervisor Sutherland spoke, stating approval of this resolution is needed to enact the Special Assessment District for Wamplers Heights road repairs. This will be a 10-year SAD, which contains 88 parcels, and an estimated total cost to residents of \$158,701.00 or \$1,803.00 per parcel ~~per year~~. Treasurer Sauers asked to have some minor spelling and dating corrections made to the document before approval. Motion was made by Supervisor Sutherland, seconded by Clerk Oswalt to approve Resolution 2022-08, Confirmation of the Roll for the Wamplers Heights SAD for road repairs, with corrections. Motion carried on a roll call vote as follows: Ayes-Sutherland, Sauers, Oswalt, Dame, and Haystead. Nays: None.
