<p>Norvell Township issues building, electrical, plumbing and mechanical permits. If work for which a permit is issued is not started within six (6) months of being issued, or if the work is abandoned for a period of six (6) months, the permit may lapse and cease to be in effect. In the absence of any inspections over a six (6) month period, Norvell Township shall cause the premises to be inspected to ascertain the work status. The respective permit applicant will be assessed a sixty five (\$65) dollar inspection fee to reimburse the cost of such status inspection. In the event the permit lapses, any unexpended amounts of the permit fee shall be used to defray related costs. If a permit has lapsed, no further work shall take place until a new permit for the remaining work has been issued in accordance with the Township fee schedule. If the applicant communicates and explains the need for an extension prior to expiration one will be granted.</p>
